Subject: February 2015 Revenue Variance Summary (Unaudited)

This report includes the Revenue Report Dashboard and Revenue Reports by Revenue Center, as well as detail reports for Petroleum, Container, Cruise, Bulk & Break Bulk, Real Estate, and Other Revenue Centers.

Operating revenues through February totaled \$73,656,082 which represents a year-over-year increase of \$1,489,391, or 2%. After consultation with Port management, a summary of variances over 5% are as follows:

Cruise – Cruise revenues through February decreased year-over-year by a total of (\$2,582,847), or (8%). As reported in the previous months, this decrease was primarily due to the dry docking of Royal Caribbean's Oasis of the Seas in Europe for the month of October. Additionally, Port User Charge revenues from Royal Caribbean decreased by \$8.1186 per passenger due to the expiration of the Capital Cost Recovery Charge on January 1, 2014. The year-over-year cumulative impact of these events on Port revenues from Royal Caribbean was (\$4,641,191). This decrease was partially offset by revenue generated in the amount of \$2,452,657 from 4, 5, and 7 day itineraries for the Caribbean Princess that were not offered as of February of the prior year, and an overall year-over-year increase in passenger volumes for multi-day and daily cruises of 6%.

Petroleum – Petroleum revenues through February increased year-over-year by a total of \$1,627,502, or 14%. As reported in the previous months, in addition to a 3% tariff increase and the new fire suppression fees which went into effect on October 1, 2014, this increase was also due to an overall year-over-year volume increase in petroleum barrels of 2,457,911, or 5%.

Real Estate – Real Estate revenues through February increased year-over-year by a total of \$351,899, or 6%. This increase was primarily due to rent adjustments associated with the appraisal of land leased by Chiquita and MSC pursuant to their lease agreements, as well as the expansion of King Ocean in Midport. In addition, easement revenue increased year-over-year by

\$72,176 due to new easements with South Florida Petroleum and FY2015 includes payments-in-lieu of rent totaling \$67,409 from the Florida East Coast Railway, L.L.C. (FEC) in connection with the operation of the Intermodal Container Transfer Facility (ICTF) which opened in July of 2014.

Midport Parking Garage – Parking revenues through February for the Midport Garage increased year-over-year by a total of \$328,215, or 11%. As reported in the previous months, this was primarily due to an increase in the number of shorter-term cruises which has a positive impact on the number of passengers choosing to park at the Port.

Northport Parking Garage – Parking revenues through February for the Northport Garage increased year-over-year by a total of \$236,086, or 16%. As in the previous months, and like the Midport Garage, this variance was primarily due to an increase in the number of shorter-term cruises which has a positive impact on the number of passengers choosing to park at the Port. The Northport Garage was additionally impacted by a 6% increase in parking for the Boat Show compared to the prior year. Also, during November, there was an overflow in all parking areas in Midport for the Thanksgiving cruises which resulted in guests being directed to park in the Northport garage.

Break Bulk – Break Bulk revenues through February increased year-over-year by a total of \$458,916, or 44%. This increase was primarily due to increases in steel imports that increased by 25,228 tons.

Bulk – Bulk revenues through February increased year-over-year by a total of \$378,406, or 48%. This increase was primarily due to increases in aggregate/cement and coal imports that increased by 81,113 ton and 35,698 tons respectively.

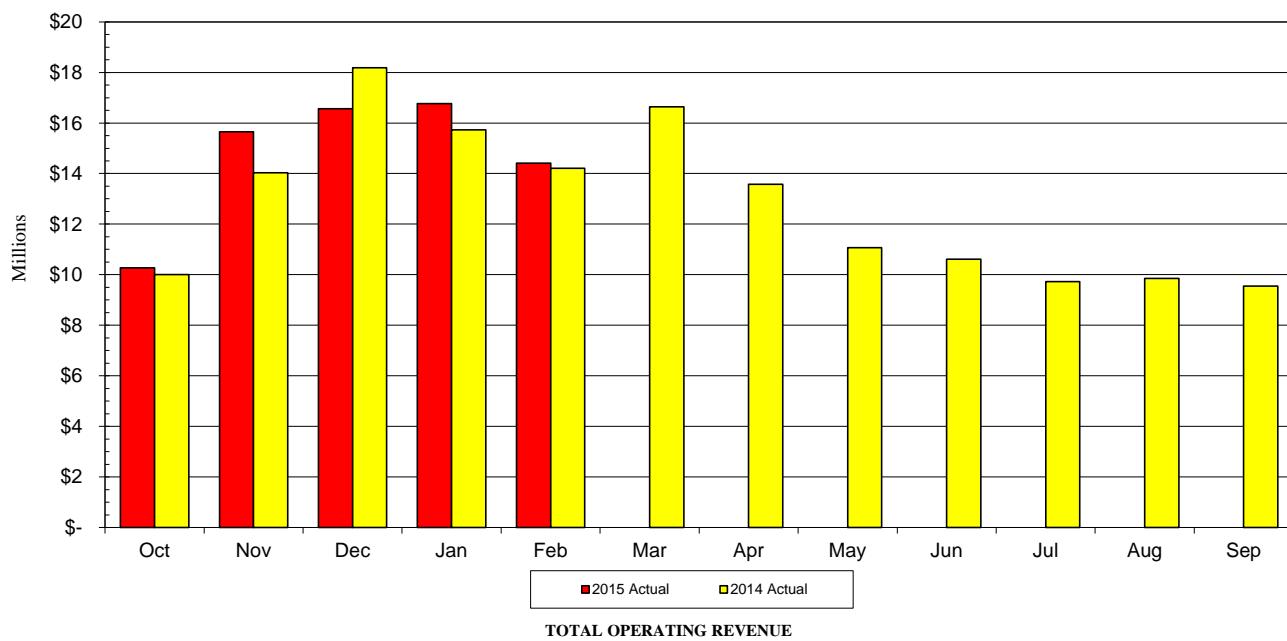

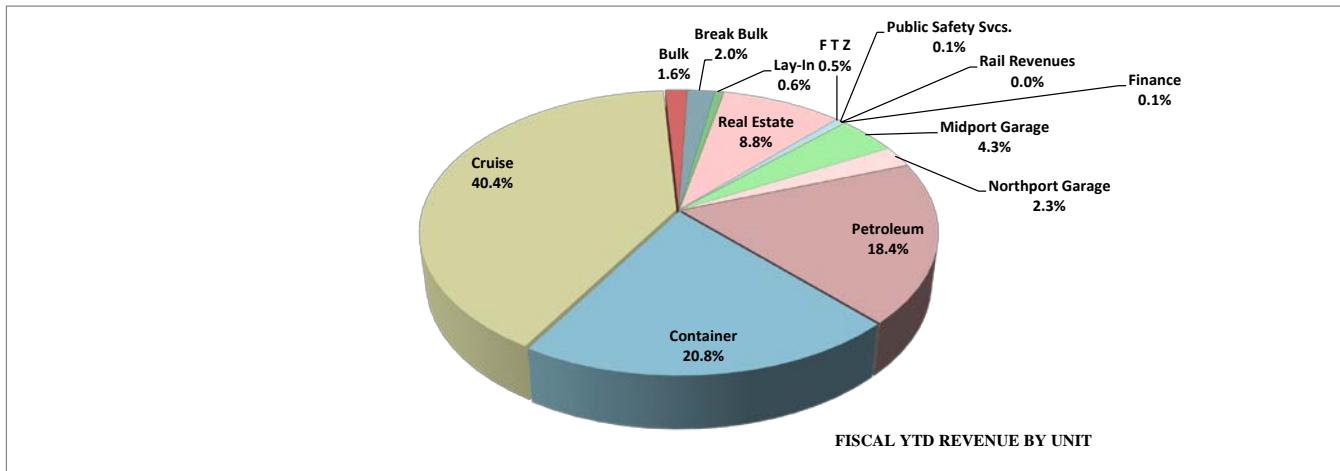

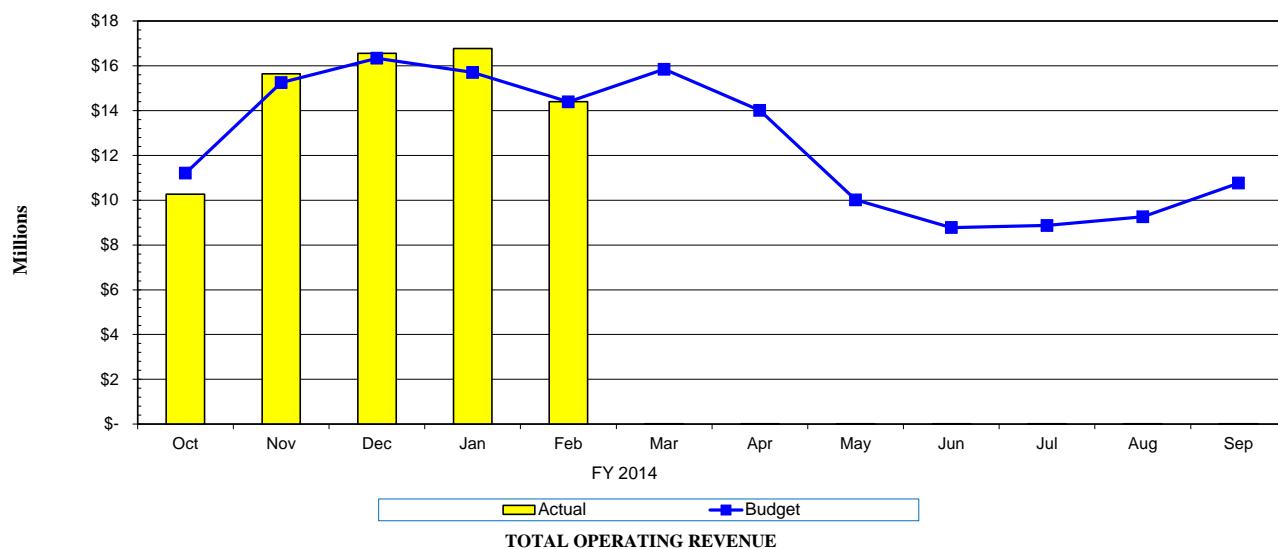
TOTAL OPERATING REVENUE
