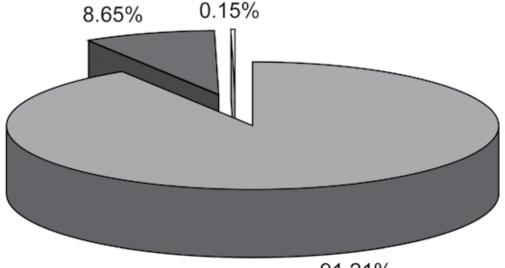

## 2012 Annual Budget Revenue Breakdown



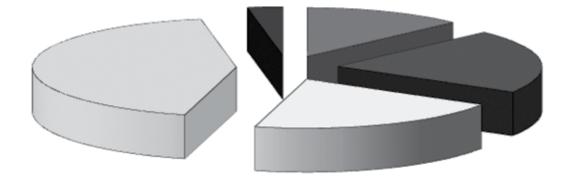
